

Utah Youth Football (UYFC) PARENT OR GUARDIAN'S PERMIT TO PARTICIPATE

I/we acknowledge that my child will engage in all activities related to the team including trying out, practicing, playing and travel.

I/we realize that such activity involves the potential for injury, which is inherent in all sports. I/we acknowledge that even with the best coaching, use of the most advanced protective equipment and strict observance to rules, injuries are still a possibility. On rare occasions these injuries can be so severe as to result in total disability, paralysis, quadriplegia or even death.

I/we acknowledge that I/we have read and understand this warning.

I/we hereby agree to exonerate and save harmless the Utah Youth Football Conference, their districts, agents, servants, including coaches, trainers, and all practitioners of the healing arts treating of my child from any and all liability, claims, causes of action or demands of any kind and nature whatsoever which may arise by or in connection with my child's participation in any activities related to football or cheerleading

BE IT KNOWN that in the event I cannot be reached, I the undersigned parent or guardian of the player above named, do hereby give and grant unto any medical doctor or hospital my consent and authorization to render such aide, treatment or care to said player as, in the judgment of said doctor or hospital may be required, on an emergency basis, in the event said player should be injured or stricken ill while participating in a Lehi Youth Football or Pioneer Youth Cheer activity.

I hereby agree to indemnify, defend, and hold harmless UYFC and its districts, and their officers, directors, members, sponsors, coaches, assistants, supervisors, representatives, and from and against any claims, demands, proceedings, investigations, or suits brought by a third party, including but not limited to, reasonable attorney fees and cost, arising out of the actions or inactions of my participating child, my family member, or me at a UYFC or district event, including but not limited to, football/cheer practices or game.

IT IS HEREBY understood that any expenses incurred will be paid for by insurance or the parent of the player. Payment of the expense is not a Lehi Youth Football or Pioneer Youth Cheer responsibility.

I hereby permit and authorize the UYFC, including their respective districts, agents, sponsors, and others acting on their behalf, to use, reproduce, and publish photographs and video that may pertain to the registered player, including the registered player's image, likeness, and voice, without compensation. I understand that this material may be used in

various publications, press releases, or recruiting materials, or for other endeavors specifically related to promotion of the sport of football. This material may also appear on the UYFC or district websites or social media pages. consequently the UYFC and home districts may publish materials, use my child's name, photograph my child, and refer to my child in any manner that the UYFC or home football districts deems appropriate to promote or publicize itself and its endeavors in relation to growing the sport of football in the state of Utah and the surrounding areas.

I/we will abide by the parent/player conduct guidelines set forth by the Utah Youth Football Conference available at utahyouthfootball.org
